DISTRICT COUNCIL AND PARLIAMENTARY CONSTITUENCY PROFILES

This paper contains comparative data for District Council and Parliamentary Constituency areas on the following: population characteristics (including age profiles and agricultural labour force); 2001 election results; and measures of deprivation (including data not previously published on income, employment, health, education, access, social environment and housing domains).

Library Research Papers are compiled for the benefit of Members of The Assembly and their personal staff. Authors are available to discuss the contents of these papers with Members and their staff but cannot advise members of the general public.

District Council and Parliamentary Constituency Profiles

The attached profile tables provide a comparison between Northern Ireland's 26 District Council areas and also between the 18 Parliamentary Constituency areas. The profiles cover three main areas: population characteristics (including age profiles and agricultural labour force); 2001 election results; and measures of deprivation (including data not previously published on income, employment, health, education, access, social environment and housing domains).¹

The tables are colour coded to facilitate easy comparisons between areas. For example, areas with the highest levels of deprivation can be readily identified from the red shaded cells in the deprivation table. The marked contrast between West Tyrone and Lagan Valley constituency areas in this respect is readily apparent.

It is hoped that this information will provide a useful supplement to information already provided by the *Northern Ireland Statistics & Research Agency (NISRA)* at ward and District Council level.² The information should be of interest to MLAs in connection with their constituency business and also to Committees within the policy context, particularly with regard to *New TSN* and the allocation of funding.

The available information relates to 1999 (except for election results). However, Research & Library Services hopes to work closely with *NISRA* to publish future updates as new information becomes available. We are also investigating the potential of geographical information systems to present future analyses of ward level data to the Assembly in a user-friendly format.




