## Summary of CAP subsidies paid by "BT" postcode prefix between 16/10/07 and 15/10/08

The following information has been provided to the Assembly Library in accordance with the responses given to Assembly Questions 5223/09, 5398/09 and 5415/09. The questions in all asked the Minister of Agriculture and Rural three cases how many farm Development and rural businesses her Department has supported in the (Upper Bann, West Tyrone and North Down) constituency in the past three years; and to indicate the amount of the investment in each case.

## The answer given in all three cases was:

"The information is not held in the form requested and could only be produced at disproportionate cost.

Details of subsidy/grant payments by recipient by European financial year to October 2007 are published on the Department's website. The Department recognises the interest shown by Members in having better information on the level of payments by area. It will arrange to collate the information on CAP, Rural Development and other grant payments for the EAGF year October 07/08, by postcode prefix level and will make that available in the Assembly Library by no later than the end of March."

## Notes

The data provided in the table below is drawn from the financial records of the Rural Payments and Inspection Division of the Department of Agriculture and Rural Development (DARD).

It represents the annual aggregate figure for payments made to recipients in each "BT" post code prefix for the EU Financial Year 2007/2008 (16/10/2007 – 15/01/2008).

The figures include payments made under both the European Agriculture Guarantee Fund (EAGF) and payments made under the European Agriculture Fund for Rural Development (EAFRD).

Examples of payments made under the European Agriculture Guarantee Fund (EAGF) are Single Farm Payment and legacy subsidy schemes i.e. Suckler Cow Premium (SCPS) and Beef Special Premium Scheme (BSPS).

Examples of payments made under the European Agriculture Fund for Rural Development (EAFRD) are Countryside Management Scheme (CMS), Less Favoured Area Compensatory Allowances Scheme (LFACA) and Farm Woodland Premium Scheme (FWPS).
