At the time I was unaware you had tabled the following Priority Question for answer on 26 June 2009 –

To ask the Minister of Enterprise, Trade and Investment (i) if she is aware of indications that Arntz Belting Company is to close two factories; (ii) whether she has any indication that the Pennyburn factory, in the Foyle constituency, may be one of the intended closures; and (iii) if she will be in contact with Arntz Belting Company to ascertain the long-term plans for the Pennyburn factory given that it has been in receipt of sizeable funding from Invest NI.

Answer:

I am aware that Optibelt, the Parent Company of Arntz Belting Company Ltd is considering a number of options as a result of global economic downturn. As yet no decision has been made to close two factories nor specific factories identified.

Invest NI officials have kept me aware of challenges facing the Arntz Belting Company factory at Pennyburn, Londonderry.

On my behalf, Invest NI continue to liaise with the Company in relation to long-term plans for the Pennyburn Factory with a view to intervening if and when appropriate. The Company have not received any funding from Invest NI since 1997. All obligations under previous offers have been fulfilled. There are, therefore, no clawback issues.
