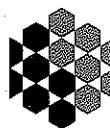

To ask the Minister for Employment and Learning to detail the number and names of individuals he has appointed to (i) public bodies; and (ii) arms-length bodies since May 2007.

Since May 2007 my predecessor, Lord Empey of Shandon, and I have made 148 new appointments, 209 re-appointments and 19 temporary re-appointments. A full breakdown for each Public Body and Arms Length Body, including the names of appointees, is detailed at Annex A.
