

PAPERS RECEIVED BETWEEN SUSPENSION AND DISSOLUTION OF THE ASSEMBLY

During the suspension of the Assembly, departments continued to lay before the Assembly accounts, reports, subordinate legislation and other documents up to the date of dissolution (28 April 2003). This was in accordance with provisions made under the Northern Ireland Act 2000.
