#### The Chairperson (Mr Cobain):

Good morning, members. We come to our clause-by-clause scrutiny of the Water and Sewerage Services (Amendment) Bill, after which we will deal with the Committee report.

#### Clause 1 (Grants to water and sewerage undertakers: extension of initial period)

#### The Chairperson:

Clause 1 deals with the extension from three to six years of the initial period for which the Department for Regional Development is required to make grants to Northern Ireland Water equal to the amount of discounts provided to customers in the initial period.
